



## **Woolwich Township Police Department**

### **Crime Log for August 2022**

- 8/1 – Officers were dispatched to a suspicious person call, in the area of Paulsboro Road, in Woolwich Township. Upon their arrival, officers located a male with multiple active warrants. The male was arrested, processed, and released with pending court dates.
- Officers responded to a theft, on Garwin Road, in Woolwich Township. Upon their arrival, they were advised a catalytic converter was stolen from a work van. Officers are following up on all leads.
- 8/2 – Officers conducted a motor vehicle stop, in the area of Oldmans Creek Road, in Woolwich Township. During the stop, officers discovered the driver of the vehicle had an active warrant. The driver was arrested, processed, and released with a pending court date.
