Crime Log for July 2022

- 7/3 Officers responded to Broad Street, in Swedesboro, for the report of a fight. Upon their arrival, officers dispersed the fight and separated the two parties. One male was arrested and charged with simple assault.
- 7/4 Officers conducted a motor vehicle stop, on Woodstown Road, in Woolwich Township. During the stop, officers discovered the driver had an active warrant for their arrest. The driver was arrested, processed, and released with a court date.
- 7/7 Officers were dispatched to Spirt Dodge, in Swedesboro, for an attempted motor vehicle theft. Upon the officer's arrival, they observed a vehicle with a smashed window and video surveillance of 2 males entering the vehicle, attempting to steal it. The vehicle was in for service and was not working properly, so the males exited the vehicle and fled the area. The Detective Unit is currently working on the incident.
- 7/7 Officers responded to CVS for the report of a trespassing complaint. Upon their arrival, officers arrested the suspect on an active warrant. The male was processed and lodged in Salem County Jail.
- 7/9 Officers responded to a missing person call in Woolwich Township. Officers quickly made contact with several different agencies and used all available recourses. Officers were able to locate the missing individual and bring him home safely.
