

Woolwich Township Police Department

Crime Log for March 2022

- 3/1 Officers responded to a theft at RT 322 and Stone Meeting House Road. It was reported that over 10 storage containers were cut open. Multiple items were taken from the site. Officers are working with surrounding jurisdictions to locate the possible suspect(s).
- 3/1 Officers responded to a suspicious person call on Ferrell Rd. The individual was found to be trespassing on private property. Officers located the male and placed him under arrest for an active warrant. Subsequent to arrest, officers found the man to be in possession of suspected heroine. The subject was charged, processed, and released on a summons, with a pending court date.
- 3/1 Officers responded to South Harrison for the report of an assault. Upon their arrival, they spoke with both parties. It was determined that one of the individuals assaulted the other.
 Officers arrested one subject and transported him to headquarters. He was processed and released on a summons, with a pending court date.
- 3/3 Officers conducted a property check of Lake Park, due to recent property damage. While
 checking the park Officers located individuals in the park after hours. These individuals were
 cited with local ordinances and released.
- 3/4 Officers conducted a motor vehicle stop on Rainey Road. During the stop Officers located
 an active warrant for the driver of the vehicle. The driver was arrested, processed, and released,
 with a pending court date.
- 3/7 Detective Unit, along with the GCPO, conducted an investigation into a child welfare case. Detectives arrested a male accused of Endangering the Welfare of a Child. The individual was charged and released with a pending court date.
- 3/8 Officers responded to an unconscious person behind the wheel of a vehicle. Upon their arrival, officers were able to determine the driver was intoxicated. Officers attempted to perform Standardized Field Sobriety Tests of the driver, but the driver refused. He was arrested, charged, and released with a pending court date.
- 3/9 Officers responded to Kings Highway for the report of a motor vehicle theft. Around 12:15 am Sunday night a Dodge Durango was stolen from a parking lot. The vehicle was valued at \$40,000. The Detective Unit conducted a follow-up investigation. On 3/10 the vehicle was located in Camden City and returned to its owner.
- 3/14 Officers conducted a motor vehicle stop, on Auburn Road, and located an active warrant
 for the driver of the vehicle. The driver was arrested, processed, and released with a pending
 court date.

- 3/18 Officers responded to the area of Locke Ave, for the report of an argument. Upon their arrival, they observed that the window of the victim's vehicle had been smashed. Officers arrested the accused. He was charged and lodged in Salem County Jail, pending a court date.
- 3/18 Officers conducted a motor vehicle stop on RT 45. During the stop, officers located an active warrant for the driver and passenger of the vehicle. The driver and passenger were arrested, processed, and released, with a pending court date.
- 3/22 Officers responded to two attempted burglaries, in the area of Rainey Road. Three males are seen on security surveillance attempting to enter a residence and the vehicles in the driveway. The suspects were unable to gain access due to the doors being locked. The Detective Unit is following up with possible leads.
- 3/22 The Detective Unit, along with the Connecticut Department of Motor Vehicles Police, worked together to locate a stolen Dodge Durango, out of Woolwich Township. On 3/24, the vehicle was located in Connecticut and returned to its owner.
- 3/23 Officers conducted a property check at Locke Ave Park, and found that the public bathrooms had been vandalized. Both bathrooms had damage to the toilets, sinks, and hand dryers, totaling approximately \$3500 in damage.
- 3/29 Officers responded to a motor vehicle crash on Rt 322 and the NJTP. No injuries were
 reported at the time. One of the two vehicles involved caught on fire. Woolwich Township Fire
 Department quickly arrived and extinguished the fire. RT 322 was closed for approximately 1
 hour while crews removed debris from the roadway.
- 3/29 Officers were notified that Wilmington Police recovered a van, that was reported stolen out of our jurisdiction. The vehicle was turned over to detectives. It was processed for evidence and released to the owner.
- 3/30 Officers conducted a motor vehicle stop on Ferrell Road in South Harrison. During the stop, Officers located an active warrant for the driver of the vehicle. The driver was arrested, processed, and released with a pending court date.
- 3/31 Officers took a report, from Township Public Works, that the bathrooms at Locke Ave Park were vandalized with spray paint.
