- 5/1 Officers conducted a motor vehicle stop on Auburn Ave in Swedesboro. While speaking with the driver it was suspected the driver was under the influence. The driver was arrested and charged with driving while intoxicated. The driver was released on a summons with a court date.
- 5/2 Officers conducted a motor vehicle stop on Monroeville Road in South Harrison Township. During the motor vehicle stop, the driver was found to have an active warrant. The driver was arrested and turned over to the State Police.
- 5/2 Officers were dispatched to Rainey Road in Woolwich Township for the report of a theft. Upon their arrival, they were advised that \$13,000 of electrical supplies were stolen from a construction site container. The Detective Unit will be conducting a follow-up investigation.
