



## **Woolwich Township Police Department**

### **Crime Log for September 2022**

9/1 – Officers conducted a motor vehicle stop, on Kings Highway, in Swedesboro. During the stop officers found the driver to be under the influence. The driver was arrested, charged, and released with a pending court date.

9/2 – Officers responded to Locke Ave Park, for the report of two stolen Bikes. The caller advised their two bikes were stolen from the swing set area as they were playing nearby.

9/5 – Officers conducted a motor vehicle stop, in the area of US RT 322, in Woolwich Township. During the stop, officers located a warrant for the driver. The driver was arrested and released with a pending court date.

9/7 – Officers responded to a domestic violence incident in Woolwich Township. On scene, officers arrested the accused for simple assault. The subject was charged and lodged in Salem County Jail.

9/9 – Officers responded to a business located in Swedesboro for a theft. The manager advised, that over the weekend, an unknown individual entered the business and stole over \$4500 from a safe. The Detective Unit will be conducting a follow-up investigation into the incident.

9/13 – Officers were dispatched, to East Ave in Swedesboro, for the report of a package theft. The suspect is described as a tall skinny male wearing a black face mask, Tupac hoodie, black pants, and black/white Nike sneakers. He is seen on camera walking onto the porch and taking a package. The Detective Unit will be investigating the theft.

9/16 –The Fatal Crash Unit, along with the Detective Unit, conducted a thorough investigation into the fatal motor vehicle accident, on US Route 322, in June of 2022. The driver of the vehicle was determined to be under the influence, at the time of the crash, and was charged accordingly.

9/19 – Officers conducted a motor vehicle stop, in the area of RT 45, in South Harrison Township. During the stop, officers located a warrant for the driver. The driver was arrested and lodged in Salem County Jail.

9/20 – The Detective Unit is investigating the theft of Catalytic Converters, from several businesses, in Swedesboro and Woolwich Township.

9/22 – Officers conducted a motor vehicle stop, in the area of Auburn Road, in Woolwich Township. During the stop, officers located a warrant for the driver. The driver was arrested and lodged in Salem County Jail.

9/22 – The Detective Unit conducted an investigation, into an assault, involving a firearm, in Swedesboro. At the conclusion, a warrant, for aggravated assault, was filed against the suspect. Officers later attempted to arrest the suspect and a foot chase ensued. After a short chase, the suspect was apprehended and lodged in Salem County Jail, on multiple charges.

9/22 – Officers responded to the Auburn Chase development, in Woolwich Township, for the report of mail theft. The driver of a black Toyota Camry is seen entering residential mailboxes and stealing mail. The Detective Unit will be conducting an investigation into the thefts.

9/22 – Officers were dispatched to a business, in Woolwich, for shoplifting. The subject was located, and the stolen items were paid for. No charges were filed at the request of the store's owner.

9/25 – Officers responded to a motor vehicle burglary in Woolwich Township. One of the articles stolen, from the vehicle, was a semi-automatic handgun. The investigation has been turned over to the Detective Unit.

9/25 – Officers responded to the Auburn Chase development, in Woolwich Township, for multiple attempted motor vehicle thefts. Subjects were seen, on camera, attempting to enter and steal several vehicles. The investigation has been turned over to the Detective Unit.

9/27 – The Detective Unit is investigating two separate alleged sexual assaults.

9/28 – The Detective Unit is investigating a child endangerment incident.

9/29 - Officers conducted a motor vehicle stop, in the area of Franklinville Road, in South Harrison Township. During the stop, officers located a warrant for the driver. The driver was arrested and released, with a pending court date.
