- 12/2 Officers conducted a motor vehicle stop at Pancoast Road and Kings Highway in Woolwich Township. During the stop, officers detected the odor of an alcoholic beverage emanating from the vehicle. The driver performed Standard Field Sobriety tests and was subsequently transported to headquarters, processed, and released with a pending court date.
- 12/4 Officers were dispatched to Kings Highway in Swedesboro for a report of a fight. Upon arrival, they identified and arrested the accused, who was then transported to headquarters, processed, and released with a pending court date.
