## **Crime Log for February 2023**

- 2/1 Officers conducted a motor vehicle stop near RT 45 in South Harrison Township. During the stop, they discovered the driver had an active warrant. The driver was arrested, processed, and released with a pending court date.
- 2/1 Officers conducted a motor vehicle stop near Auburn Road in Swedesboro. They discovered the driver had an active warrant and subsequently arrested, processed, and released the driver with a pending court date.
- 2/6 Officers were dispatched to Wawa in Woolwich Township following a report of shoplifting. A juvenile had entered the store, stolen several items, and left. Security footage identified the juvenile, whose guardians were then contacted. The store manager requested the juvenile return and pay for the items.
- 2/6 Officers conducted a motor vehicle stop at the intersection of Kings Highway and Oldmans Creek Road in Woolwich Township. The driver was found to have an active warrant, leading to their arrest, processing, and release with a pending court date.
