- 1/1: Officers responded to a report of a stolen items at a residence in Woolwich. The stolen items included a laptop, jewelry, and a firearm. The investigation was handed over to the Woolwich Township Detectives Unit.
- 1/2: Officers conducted a motor vehicle stop on RT 322 in Woolwich and discovered that the driver had active warrants. The driver was arrested, processed, and released pending a court date.
