- 3/1 Officers were dispatched to Kingsway High School for a harassment incident. A juvenile was charged and released to their parent with a pending court date.
- 3/2 Officers conducted a motor vehicle stop in the area of Franklin Street in Swedesboro. During the stop, officers found several warrants for the driver. The driver was arrested and turned over to the New Jersey State Police.
