- 5/1 Officers conducted a motor vehicle stop in the area of Monroeville in South Harrison Township. During the stop, officers located several active warrants for the driver. The driver was arrested, processed, and released with a pending court date.
- 5/1 Officers were dispatched to an overdose. Officers quickly administered Narcan and conducted life-saving measures. The individual regained consciousness and was treated by Gloucester County EMS.

Officers completed field sobriety testing on the driver. The driver was arrested, charged, and released with a pending court date.
