Crime Log for November 2023

- 11/5 Officers were dispatched to Shoprite for the report of a shoplifting. Upon the officer's arrival, they spoke with the security guard and were shown a video of the suspect attempting to shoplift less than \$500.00 worth of groceries. Officers arrested the suspect and transported them back to headquarters. Once at headquarters, they were processed, charged, and released with a pending court date.
- 11/8 Officers conducted a motor vehicle stop in the area of Ferrell Road in South Harrison Township. During the stop, officers located an active warrant for the driver. The driver was arrested, transported back to headquarters, processed and turned over to the Millville Police Department.
- 11/13 Officers were dispatched to a motor vehicle crash in the area of Oldmans Creek Road and Hunters Run in Woolwich Township. Upon Officer's arrival, they observed a vehicle with heavy front-end damage and a telephone pole snapped in half. No occupants were observed around or in the vehicle. Officers checked the area and located a male walking down Oldmans Creek Road. The male stated he had crashed his vehicle and was walking home. The officer detected the odor of an alcoholic beverage emanating from the individual. Standard Field Sobriety Testing was conducted on the driver. The driver was found to be under the influence and was arrested, charged, and released with a pending court date.
- 11/15 Officer conducted a motor vehicle stop in the area of Village Green Drive. During the stop, officers located an active warrant for the driver. The driver was arrested, transported back to headquarters, processed, and released with a pending court date.
