Crime Log for April 2022

- 4/1 - Officers conducted a property check of Locke Ave Park. While conducting a check of the storage facility, officers observed damage to the door. The door appeared to be kicked in and the lock was broken. Nothing appeared to be missing from the building at this time.
- 4/1 - Officers conducted a motor vehicle stop on Kings Highway, in Swedesboro. Officers gathered reasonable articulated suspicion and conducted a consent search of the vehicle. Officers located drug paraphernalia while searching. The driver of the vehicle was arrested, processed, and released on a summons, with a pending court date.
- 4/2 - Officers responded to a criminal mischief complaint, in the area of Broad Street, in Swedesboro. Officers took a report of 4 separate vehicles with slashed tires, in a parking lot. Officers are investigating and gathering surveillance footage.
- 4/3 - Officers conducted a motor vehicle stop, on Monroeville Road, in South Harrison. After identifying the driver, it was found that they had an active traffic warrant. The driver was arrested and released with a new court date.
- 4/5 - Officers conducted a motor vehicle stop on Kings Highway, in Swedesboro. The driver was found to have an active criminal warrant. The driver was arrested and released with a new court date.
- 4/8 - Officers conducted a motor vehicle stop on Center Square Road, in Woolwich Township. The driver was found to have an active warrant. The driver of the vehicle was arrested and released with a new court date.
- 4/8 - Officers responded to the report of theft, at AT&T, on RT 322. It was reported that 5 iPhone 13 pros, worth over \$5,000, were stolen. During the course of the investigation, officers identified one of the suspects involved. The suspect was charged and given a pending court date.
- 4/10 - Officers responded to a theft at Locke Ave Park. Upon their arrival, they were informed by a witness, that a black male exited a black SUV and walked over to the victim's unoccupied vehicle. The male then smashed the window of the victim's vehicle, and stole personal items, before fleeing in the SUV. Detectives are conducting an investigation.
- 4/11 - Officers conducted a motor vehicle stop, on Monroeville Road, in South Harrison. The driver was found to have an active warrant. The driver was arrested and released with a new court date.

- 4/11 - Officers responded to CVS, on RT 322, for the report of a theft. Upon their arrival, they were informed that two black males used counterfeit 100-dollar bills to purchase gift cards. The males then left the store in a black sedan. We believe this is related to Logan Township and Harrison Township counterfeit money scams. Detectives are working with surrounding jurisdictions.
- 4/12 - Officers conducted a motor vehicle stop, on RT 322, in Woolwich Township. The driver was found to have an active warrant. The driver was arrested and lodged in Salem County Jail.
- 4/12 - Officers conducted a motor vehicle stop, on Township Line Road, in Woolwich Township. The driver was found to have an active warrant. A search of the vehicle was conducted. Suspected narcotics and drug paraphernalia were located. The driver of the vehicle was arrested, processed, and released with a new court date.
- 4/13 - Officers conducted a motor vehicle stop, on Mullica Hill Road, in South Harrison. The driver was found to have an active warrant. The vehicle was searched, and officers located suspected narcotics and drug paraphernalia. The driver of the vehicle was arrested and released with a new court date.
