Crime Log for October 2022

10/1 - Officers responded to Swedesboro for a dwelling fire. Officers quickly secured the scene, while Woolwich Township Fire Department extinguished the fire.

10/2 - Officers responded to a stolen motor vehicle on Franklinville Road, in Woolwich Township. The vehicle was stolen from the residence in the overnight hours. The Detective Unit located the vehicle several hours later and had it returned to the owner.

10/2 - Officers responded to an attempted burglary, in Woolwich Township. Two subjects attempted to enter the home of a residence. They quickly fled the area when they realized the door was locked. The subjects are linked to a stolen motor vehicle case.
