

## **Woolwich Township Police Department**

## Crime Log for April 2024

Woolwich Township Police Department handled a total of 2,796 proactive and reactive calls for service. This included: 7 assaults, 5 burglaries (residential and vehicle), 11 domestic violence-related incidents, 33 motor vehicle crashes, 13 thefts, 4 shopliftings, 3 stolen motor vehicles, 19 suspicious incidents, and 18 arrests (2 DWI/traffic offenses, 3 warrants, 5 simple assaults, 3 contempt of court, 4 shopliftings, 1 other).

- April 2, 2024 Patrol units were dispatched to Broad Street for a reported attempted burglary of a residence. Signs of forced entry were observed, but entry was not gained. The investigation is ongoing.
- April 2, 2024 Patrol units were dispatched to Pancoast Road for a domestic violence incident. The investigation concluded with the primary aggressor being charged with simple assault due to visible signs of injuries. The suspect was arrested, processed, and released on a summons pending a future court date.
- April 6, 2024 Patrol units responded to the area of Oldmans Creek Road for a reported stolen motor vehicle. The vehicle was briefly observed by Logan Township Police but fled from the motor vehicle stop. Due to safety concerns, the pursuit was terminated. The vehicle was later located in Virginia by law enforcement. The suspect was taken into custody in Virginia for criminal charges, with additional charges pending out of Woolwich Township.
- April 10, 2024 Patrol units were dispatched to the area of Rt. 322 for a domestic violence incident. The investigation concluded with the primary aggressor being charged with simple assault due to visible injuries. The suspect was processed and released on a summons pending a future court date but was subsequently turned over to an outside law enforcement agency due to an outstanding warrant.
- April 10, 2024 Patrol units were dispatched to the Wawa for the theft of \$20.00 worth
  of gasoline. The investigation identified the suspect operating the vehicle, and a summons
  for theft was issued.
- April 11, 2024 Due to numerous complaints of shoplifting at the Wawa, proactive patrol units were able to intercept and apprehend two subjects, who were subsequently charged with shoplifting and released on a summons pending a future court date.
- April 11, 2024 Two shoplifters were intercepted by ShopRite Loss Prevention and subsequently arrested by patrol units for shoplifting. The two subjects were processed and released on a summons pending a future court date.

- April 21, 2024 Patrol units were dispatched to Maple Avenue for a domestic violence incident. Upon the conclusion of the investigation, the primary aggressor was arrested for simple assault due to visible signs of injury. The suspect was arrested, processed, and released on a summons pending a future court date.
- April 23, 2024 Patrol units were dispatched to Locke Avenue Park for a reported theft of artificial turf. Preliminary investigation indicates approximately 10 feet of turf was removed from a larger pile that was donated to be used in the baseball bullpens. The suspect has not been identified, and the investigation is ongoing.
- April 24, 2024 Patrol units were dispatched to Locke Ave Park around 6 pm for a vehicle burglary. It was found that the vehicle had a window smashed and a wallet stolen. Credit cards taken from the burglary were used at other locations. The investigation is ongoing.
- April 27, 2024 Patrol units were dispatched to the area of Railroad Avenue for a
  domestic violence incident. The investigation concluded with the primary aggressor
  being arrested for simple assault. The subject was transported and logged in Salem
  County Correctional Facility due to an out-of-state warrant.
- April 27, 2024 Patrol units arrived on the scene of a traffic stop conducted by an
  outside law enforcement agency after receiving a complaint of an erratic driver on Center
  Square Road. Patrol units investigated the complaint, which resulted in the driver being
  charged with driving while intoxicated. The driver was arrested, processed, and released
  on citation pending a future court date.
