



Woolwich Township Police Department

Crime Log for August 2024

During August 2024, the Woolwich Township Police Department managed 3,126 proactive and reactive calls for service. These included 410 Motor Vehicle Stops; 89 Targeted Radar Enforcement; 34 Motor Vehicle Crashes; 28 Motor Vehicle Complaints; 8 Threats; 4 Domestic Violence Incidents; 5 Harassments; 3 Shopliftings; 3 Assaults; and 11 Arrests (4 Warrants, 3 DWIs, 2 Assaults, and 2 Contempt of Court).

August 1, 2024 – Burglary (Swedesboro): Patrol responded to a residence that had their door kicked in. No property was taken.

August 2, 2024 – Motor Vehicle Stop (Woolwich Twp): During a motor vehicle stop, it was discovered that the operator had an active out of county warrant for their arrest. The suspect was arrested, processed, and released on their own recognizance with a new court date.

August 4, 2024 – Motor Vehicle Stop (Woolwich Twp): During a motor vehicle stop, it was discovered that the operator had an active warrant for their arrest. The suspect was given a new court date and released on their own recognizance.

August 4, 2024 – Warrant Arrest (South Harrison): During a motor vehicle stop, it was found the operator had an active warrant for their arrest. The suspect was arrested, processed, and transported to the Salem County Correctional Facility for housing.

August 6, 2024 – Stolen Motor Vehicle/Theft (Swedesboro/Woolwich Twp): Patrol and Detective Unit responded and handled numerous thefts from motor vehicles and one stolen motor vehicle overnight. The stolen vehicle was later recovered.

August 6, 2024 – Warrant Arrest (Swedesboro): While conducting an added patrol, officers located a subject with active warrants. They were arrested, processed, and released pending a new court date.

August 7, 2024 – Fraud (Woolwich Twp): Fraudulent use of airline miles reported to patrol.

August 7, 2024 - Domestic (South Harrison): Patrol units dispatched to domestic violence incident. Investigation concluded with the suspect arrested, processed, and released pending court date for simple assault.

August 8, 2024 – DUI (Woolwich Twp): Patrol unit was dispatched to a subject slumped over the wheel of a vehicle. Narcotics was located and the subject was charged with driving while intoxicated after being medically cleared.

August 9, 2024 – Fraud (South Harrison): Patrol investigated a report of fraudulent telephone accounts being opened in the victim's name.

August 11, 2024 – Vehicle Burglaries (Swedesboro/Woolwich Twp): Approximately ten motor vehicles were burglarized overnight after being unlocked.

August 11, 2024 – Stolen Motor Vehicles (Swedesboro/Woolwich Twp): Two motor vehicles were stolen after being left unlocked with the keys inside.

August 12, 2024 – Recovered Stolen Vehicle (Swedesboro): A stolen vehicle from Wilmington, DE was recovered by Patrol and processed by the Detective Unit.

August 12, 2024 – Recovered Stolen Vehicle (Woolwich Twp): A stolen vehicle out of this jurisdiction was located and recovered in Wilmington, DE.

August 12, 2024 – Stolen Motorcycle (Woolwich Twp): Patrol and Detective Unit responded to an overnight theft of a motorcycle which included damage to the vehicle.

August 14, 2024 – Burglary/Theft (Swedesboro): Patrol units received a report of theft from an unlocked motor vehicle that occurred overnight.

August 14, 2024 – Motor Vehicle Stop (Woolwich Twp): During a motor vehicle stop, it was found the operator had two active warrants. The operator was given new court dates and released on their own recognizance.

August 15, 2024 – Commercial Burglary (Swedesboro): Patrol and Detective Unit responded to a burglary/theft of a local business, in which an excess of \$50,000 was stolen.

August 17, 2024 – Recovered Stolen Vehicle (Woolwich Twp): A stolen vehicle out of this jurisdiction was located and recovered in Broomall, PA.

August 20, 2024 – Shoplifting (Woolwich Twp): Patrol responded to a delayed report for shoplifting at the AT&T.

August 22, 2024 – Two Vehicle Crash (South Harrison): Patrol units responded to a two-vehicle crash at Monroeville Road and U.S. Route 45 with injuries. Concluded with occupants being transported for medical treatment.

August 24, 2024 – Assault (Woolwich Twp): Patrol units were dispatched to an assault. At the conclusion of the investigation, one subject was arrested for assault.

August 25, 2024 – Theft (Woolwich Twp): Patrol units respond to the Wawa for theft of gasoline.

August 28, 2024 – Illegal Dumping (Woolwich Twp): Patrol units received a complaint for illegal dumping at a construction site located within the jurisdiction.

August 28, 2024 – Criminal Mischief (Woolwich Twp): Complainant reporting damage to their vehicle while parked at a local business. Investigation concluded by Patrol.

August 30, 2024 – Motor Vehicle Stop (Woolwich Twp): After a motor vehicle stop by Patrol Units, the operator was found to have an active warrant. They were released on their own recognizance and given a new court date.

August 31, 2024 – Burglary (South Harrison): Patrol units responded to a residential burglary. Investigation on-going and being assisted by the Detective Unit.
