



Woolwich Township Police Department

Crime Log for June 2024

During June 2024, the Woolwich Township Police Department managed 2,724 proactive and reactive calls for service. This included: 126 Added Patrols, 85 Burglar Alarm Activations, 9 Harassment Calls, 22 Juvenile Complaints, 28 Motor Vehicle Complaints, 46 Motor Vehicle Crashes, 384 Motor Vehicle Stops, 52 Incidents of Suspicious Activity (Incidents, Motor Vehicles, Persons), and 8 Arrests (4 Warrants, 3 Assaults, and 1 DUI). **June 1, 2024:** Patrol units responded to Glen Echo Avenue and Franklin Street (Swedesboro) for a motor vehicle complaint. Upon conducting a motor vehicle stop, the operator was arrested for driving while intoxicated, processed, and released pending a future court date.

- **June 3, 2024:** Patrol units responded to the area of Second Street (Swedesboro) for an unwanted person. Upon their arrival, it was found to be a verbal altercation that was resolved, and both parties went their separate ways.
- **June 4, 2024:** Patrol units were dispatched to Lexington Mews (Woolwich Twp.) for reported threats involving a knife. Upon their arrival, it was determined to be a psychological episode which concluded with no danger present and appropriate assistance being rendered.
- **June 7, 2024:** Patrol units were dispatched to Wawa (Woolwich Twp.) for shoplifting. Upon their arrival, the suspect was identified. Contact was made with the suspect, and Wawa declined to pursue criminal charges after payment was rendered.
- **June 7, 2024:** Patrol units were dispatched to Lincoln Road and Linwood Drive (South Harrison) for a motor vehicle crash involving a single vehicle into a tree. The driver sustained minor injuries and was treated by medical professionals.
- **June 7, 2024:** Patrol units responded to a report of packages being stolen from a porch on Mechanic Street (Swedesboro).
- **June 9, 2024:** Patrol units responded to U.S. Route 322 (Woolwich Twp.) for a road rage incident in which the suspect stopped their vehicle in front of the victim, exited, and punched the car, resulting in damage before fleeing. The investigation is ongoing.
- **June 9, 2024:** Patrol units were dispatched to Kirschling Drive (Woolwich Twp.) for the report of a stolen grill.
- **June 9, 2024:** Patrol units were dispatched to Copper Road (Woolwich Twp.) to investigate harassing phone calls being received from an unknown phone number.

- **June 10, 2024:** Patrol units were dispatched to Route 45 and Monroeville Road (South Harrison) for a three-vehicle crash, with one striking a pole. Minor injuries were reported, and the roadway was opened after the scene was cleared.
- **June 10, 2024:** Patrol units were dispatched to Commissioners Road (South Harrison) for a report of harassment/threats via text messages.
- **June 10, 2024:** Patrol units were dispatched to Back Creek Road (Woolwich Twp.) for reported threats/harassment involving juveniles. The investigation was conducted with the assistance of our School Resource Officers (SROs).
- **June 11, 2024:** Patrol units responded to Westbrook Drive (Woolwich Twp.) for a single motor vehicle crash. The vehicle exited the lane of travel, hopped the curb, and struck a sign. No other injuries or damage were reported.
- **June 13, 2024:** Patrol units were dispatched to Wawa (Woolwich Twp.) for shoplifting. The suspect was identified and contacted. The suspect later turned themselves in to the Woolwich Twp. Police Department, where they were charged with shoplifting via summons and released pending a future court date.
- **June 13, 2024:** Patrol units were dispatched to Yorktown Road (Woolwich Twp.) for a residential burglary. Upon their arrival, the scene was secured, and the Woolwich Twp. Detective Unit responded to further the investigation.
- **June 13, 2024:** Patrol units conducted a motor vehicle stop at the Heritages Store (Swedesboro) in which the driver was found to have an active warrant. The driver was released on their own recognizance and given a new court date.
- **June 14, 2024:** Patrol units conducted a motor vehicle stop on Center Square Road (Woolwich Twp.), resulting in the operator being placed under arrest for an active warrant and subsequently turned over to the issuing agency.
- **June 14, 2024:** Patrol units were dispatched to ShopRite (Woolwich Twp.) for a hit-and-run motor vehicle crash. The investigation was able to identify the suspect vehicle and driver. A crash report was completed, and a traffic citation was issued.
- **June 14, 2024:** Patrol units were dispatched to Westbrook Drive (Woolwich Twp.) for a medical call. Upon their arrival, it appeared the subject was under the influence and required medical attention. While attempting to transport the subject, they became combative towards medical professionals and police, resulting in the subject being criminally charged with aggravated assault on medical services.
- **June 17, 2024:** Patrol units were dispatched to Park Avenue (Swedesboro) for a domestic violence incident. The call for service concluded without incident and no arrests were made.

- **June 19, 2024:** Patrol units were dispatched to Wawa (Woolwich Twp.) for theft of gas. The investigation is ongoing.
- **June 20, 2024:** Patrol units conducted a traffic stop at ShopRite (Woolwich Twp.), resulting in the operator being placed under arrest for an active warrant and subsequently turned over to the issuing agency.
- **June 20, 2024:** Patrol units were dispatched to Route 45 and Monroeville Road (South Harrison) for a two-vehicle crash with minor injuries.
- **June 20, 2024:** Patrol units were dispatched to Wawa (Woolwich Twp.) for an incident of theft in which two apparent juveniles entered the store and removed store property from the wall before leaving the scene.
- **June 22, 2024:** Patrol units were dispatched to Evelyn Way (Woolwich Twp.) for a domestic violence incident. The investigation concluded with one party being placed under arrest for simple assault, processed, and released on a summons pending a future court date.
- **June 24, 2024:** Patrol units were dispatched to Route 45 and Monroeville Road (South Harrison) for a single-vehicle crash. No injuries were reported, only damage to a stop sign.
- **June 24, 2024:** Patrol units were dispatched to Locke Ave Park for a report of criminal mischief. It was determined that the subject broke a bathroom mirror on location. The investigation is ongoing.
- **June 25, 2024:** Patrol units assisted Logan Township Police in locating a subject wanted for causing a disturbance at the Tractor Supply. Upon locating the subject on Center Square Road (Woolwich Twp.), Logan Twp. Police were advised and responded to the scene.
- **June 27, 2024:** Patrol units responded to JB Liquors (Woolwich Twp.) for a reported shoplifting in which two suspects entered the store and stole approximately \$100-200 worth of merchandise.
- **June 30, 2024:** Patrol units were dispatched to Maple Ave (South Harrison) for a dispute. The investigation concluded with one party being arrested for domestic violence simple assault. The suspect was processed and released pending a future court date.
