

Woolwich Township Police Department

Crime Log for May 2024

For May of 2024, the Woolwich Township Police Department managed a total of 2,814 proactive and reactive calls for service. This included: 12 assaults, 1 burglary, 11 domestic violence-related incidents, 41 motor vehicle crashes, 6 thefts, 3 shopliftings, 9 suspicious incidents, 9 harassment complaints, 16 juvenile complaints, 19 motor vehicle complaints, and 7 arrests.

- May 2, 2024: Patrol units were dispatched to a call for a disturbance in the area of Franklin Ave (Swedesboro). Upon the officer's arrival, it was found that the accused had several active warrants. The suspect was arrested, processed, and lodged in Salem County Jail with a pending court date.
- May 3, 2024: Patrol units were dispatched to a call for a disturbance in the area of Westbrook Drive (Woolwich Township). Upon the officer's arrival, it was found that the accused had assaulted the victim during an argument. The suspect was arrested, processed, and released with a pending court date.
- May 5, 2024: Patrol units were dispatched to Kinsale Lane (Woolwich) for a report of burglary. Units found the residence had been gone through and damage was found. Investigation ongoing.
- May 9, 2024: Patrol units were dispatched to the General Harker School (Woolwich) for a report of property damage. It was found that a vehicle located in the parking lot sustained a broken window. No other damage reported. Investigation ongoing.
- May 10, 2024: Patrol units came upon a dispute between two individuals while at Locke Ave Park (Woolwich). Interaction was determined to be verbal only, and no arrests were made.
- May 11, 2024: Patrol units were dispatched to a call for a disturbance in the area of Westbrook Drive (Woolwich Township). Upon the officer's arrival, it was found that the accused had assaulted the victim during an argument. The suspect was arrested, processed, and released with a pending court date.
- May 14, 2024: Patrol units conducted a motor vehicle stop in the area of Oldmans Creek Road and Auburn Ave (Woolwich Township). During the stop, officers located an active warrant for the driver of the vehicle. The driver was arrested, processed, and released with a pending court date.

- May 14, 2024: Patrol units were dispatched to the area of Auburn Road and Oldmans Creek Road (Woolwich) for a found firearm. The firearm appeared to have been discarded onto the side of the road loaded with a defaced serial number. Investigation turned over to the Detective Unit.
- May 15, 2024: Patrol units were dispatched to the CVS (Rt. 322, Woolwich) for a report of shoplifting. It was discovered that four individuals entered the CVS and stole approximately \$8,000.00 worth of cosmetic merchandise. Investigation turned over to the Detective Unit.
- May 18, 2024: The detective unit was contacted by the Galloway Township Police Department in reference to a burglary case at the Swedesboro car wash that took place in January. Officers in Galloway arrested several suspects possibly linked to the car wash burglary. Detectives will be following up with all suspects and leads.
- May 22, 2024: Patrol units were able to locate a suspect wanted out of Philadelphia for several crimes when he arrived at court. The suspect was arrested and lodged in Salem County Jail awaiting extradition back to Philadelphia.
- May 22, 2024: Patrol units were dispatched to Foxford Lane (South Harrison) for residential burglary and theft. Investigation turned over to the Detective Unit regarding the approximate theft of \$20,000 worth of items.
- May 24, 2024: Patrol units were dispatched to Salvatore Circle (Woolwich) for a report of theft. Upon their arrival, it was determined that a theft of the victim's delivered package had occurred. Investigation ongoing.
- May 24, 2024: A resident on Ashburn Way (Woolwich) reported illegal dumping of trash within their dumpster.
- May 25, 2024: Patrol units were dispatched to the Wawa (Paulsboro Road, Woolwich) for a report of shoplifting. An unknown suspect stole approximately \$25.00 worth of property and left the area.
- May 25, 2024: Patrol units were dispatched to a criminal mischief incident around Railroad Avenue (Swedesboro). It was found the back windows of a vehicle were broken. No other damage was reported in the area.
- May 29, 2024: Patrol units conducted a motor vehicle stop in the area of Rt 45 and Franklinville Road in South Harrison Township. During the stop, officers located an active warrant for the driver of the vehicle. The driver was arrested, processed, and released with a pending court date.
