Crime Log for September 2024

During September 2024, the Woolwich Township Police Department managed 2,863 proactive and reactive calls for service. These included 320 Motor Vehicle Stops; 80 Targeted Radar Enforcement; 39 Motor Vehicle Crashes; 27 Motor Vehicle Complaints; 8 Threats; 5 Domestic Violence Incidents; 8 Harassments; 8 Assaults; and 14-Arrests (5-Warrants, 1-DWI, 1-Simple Assault, 1-Aggravated Assault, 1-Criminal Mischief, 3-Contempt of Court, 1-Disorderly Conduct, and 1-Fugitive from Justice).

- September 1, 2024: Patrol units responded to a residential burglary in the southern area of Woolwich Township. The investigation is ongoing.
- September 1, 2024: Patrol units responded to a fraud complaint in the northern area of Woolwich Township. Initial investigation revealed that the victim was defrauded via the internet out of approximately \$2,000.00.
- September 1, 2024: Patrol units responded to High Hill Park (Woolwich Township) for a report of graffiti. The graffiti was subsequently removed with the assistance of Public Works.
- September 1, 2024: Patrol units located an individual trespassing along the railroad tracks nearest Paulsboro Road (Woolwich Twp). Upon contact, it was learned that the subject had an active warrant for their arrest. They were arrested, transported to police headquarters, processed, and released pending a future court date.
- September 1, 2024: Patrol units were dispatched to Kings Highway (Swedesboro) for an unwanted person. It was found that the subject had an active out-of-state warrant. They were subsequently arrested and transported to the Salem County Correctional Facility.
- September 2, 2024: Patrol units investigated a disabled/unattended motor vehicle along Oldmans Creek Road (Woolwich Township). It was revealed that the vehicle was stolen. The vehicle was towed from the scene and the originating agency was advised.
- September 2, 2024: Patrol units responded to the intersection of U.S. Route 322 and the New Jersey Turnpike (Woolwich Twp) for a fatal motor vehicle crash. The investigation is ongoing by Woolwich Township Police Department's Fatal Crash Investigators and the Detective Unit.
- September 4, 2024: Patrol units received a fraud complaint in which the victim's bank account was accessed without their approval (Woolwich Township).

- September 9, 2024: Patrol units were advised of an illegal dumping complaint occurring in the area of Merseyside Dr. (Woolwich Twp).
- September 9, 2024: Patrol units were dispatched to the Windsor Dr. (Woolwich Twp) for a complaint of identity theft.
- September 10, 2024: Patrol units were dispatched to the Margaret Clifford School (Swedesboro) for a report of criminal mischief.
- September 10, 2024: Patrol units were dispatched to Locke Ave (Woolwich Twp) for a disturbance. Upon their arrival, the incident was resolved without further police involvement necessary.
- September 10, 2024: Patrol units were dispatched to Heritages (Swedesboro) for a reported assault.
- September 11, 2024: Patrol units were dispatched to Fiducioso Ave (Woolwich Twp) for a reported stolen vehicle. The vehicle was determined to have been taken without the owner's consent, and the incident was resolved.
- September 11, 2024: Patrol units responded to Weatherby Ave (Swedesboro) for a report of a license plate stolen from a motorcycle.
- September 13, 2024: Patrol units responded to Westbrook Dr (Woolwich Twp) for a report of theft from a motor vehicle.
- September 13, 2024: Subsequent to a motor vehicle stop, the operator was arrested for driving while intoxicated.
- September 14, 2024: Patrol units responded to Broad St (Swedesboro) for a report of criminal mischief. It was reported tires of a vehicle were damaged, as well as the paint was scratched.
- September 14, 2024: Patrol units were dispatched to Westbrook Dr (Woolwich Twp) for a large fight.
- September 18, 2024: Patrol units were dispatched to Lake Ave (Swedesboro) for a report of a vehicle taken without its owner's consent.

- September 18, 2024: Patrol observed a subject known to law enforcement to have an active warrant for their arrest. The subject was arrested and subsequently transported to the Salem County Correctional Facility for the warrant.
- September 19, 2024: During a motor vehicle stop in the area of Eldridges Hill Rd (South Harrison Twp), the operator was found to have an active warrant for their arrest. The subject was subsequently released on their own recognizance with a pending court date.
- September 22, 2024: Patrol units dispatched to Second St (Swedesboro) for a reported motor vehicle crash hit and run.
- September 22, 2024: Patrol units were dispatched to Franklinville Rd (South Harrison Twp) for a report of illegal dumping.
- September 23, 2024: Patrol units were dispatched to Lincoln Rd (South Harrison Twp) for a motor vehicle burglary, in which property inside was attempted to be stolen.
- September 23, 2024: Patrol units were dispatched to Park Ave (Swedesboro) for a reported fight.
- September 25, 2024: Patrol units were dispatched to Fiducioso Ave (Woolwich Twp) in response to a reported dispute. One subject was arrested and later released.
- September 28, 2024: It was reported to patrol units that an individual had failed to return rented construction equipment from Sunbelt Rentals (Woolwich Twp).
